3- RESULTS:

The percentage of participation by the targeted participants in the research questionnaire (residents of the city of Mecca) was 25-60 years old. Their participation rate was as follows: from 25-34 years old, 33.3%, and from 35-44 years old, 44.4%. Age 45-54 years 22.2%, no participation from those aged 55-60 years. As for the gender of the participants, the percentage of males participating in the questionnaire was 61.1%, and the percentage of females was 38.9%, and all of their nationalities were 100% Saudi. Their occupations were distributed as follows: student 22.2%, government employee 55.6%, private sector employee 11.1%, housewife 0%, self-employed 0%. As for their educational status, their educational qualifications were as follows: neither see nor write

0%, primary 0%, middle school 0%, secondary school 0%, diploma 5.6%, university 72.2%, master's 22.2%, doctorate 0%. 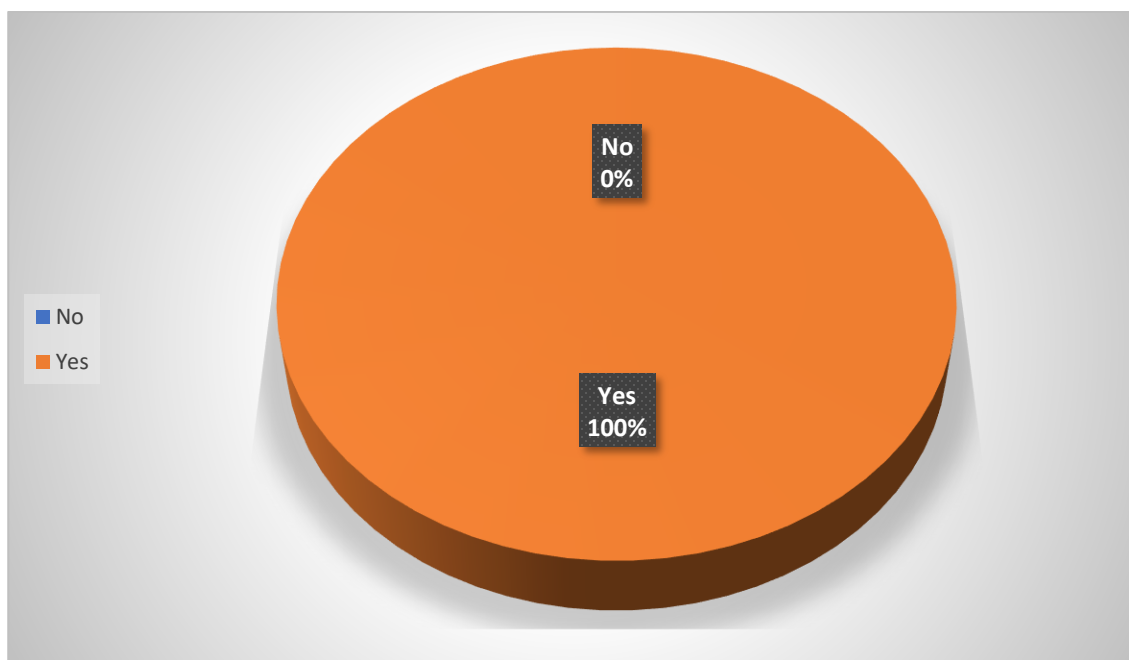
Social care is part of social service, they have a strong relationship, they both care about humans and their requirements. the use of social workers in many social
